Integration of Female Migrant Domestic Workers: Strategies for Employment and Civic Participation

The project *Integration of Female Migrant Domestic Workers* funded by the European Commission INTI Preparatory Actions came to a close on the 28th February 2008 with the Final International Conference that took place at the University of Nicosia, Cyprus.

The main aim of the 18-month project was to stimulate transnational cooperation involving a wide range of actors at the local, regional and EU level, in order to develop recommendations for an integration model responding to the specific needs of female migrant domestic workers and their host countries and adaptable to different contexts.

The conference was attended by a wide range of actors on a national and EU level including NGO representatives, policy makers, public authorities, representatives of international and local migrant organizations, experts in the field of migration and gender studies, as well as representatives from the partner organisations from Spain, Italy, Greece and Germany.



Daphne II – Date Rape among Young Women and the Development of Good Practices for Support and Prevention

MIGS recently completed the project *Date Rape Cases Among Young Women and the Development of Good Practices for Support and Prevention*, funded by the Daphne II Programme of the European Commission.

The project concluded its final phase with the organization of a Final Conference that took place in Nicosia, Cyprus and the publication of a Resource Book consisting of the results of the research conducted in the five partner countries, as well as good practice examples and policy recommendations on a national and EU level. Five country research reports have also been finalized based on the collection of comprehensive data, information and material through quantitative and qualitative research carried out in each partner country. The research aimed at measuring the prevalence and incidence of date rape among female college students and assessing the attitudes, behaviors and level of awareness among beneficiaries and target groups.

Final International Conference


As a closing activity MIGS organized a Final Conference aimed at the exchange of knowledge and best practice for the prevention of date rape and sexual violence in Europe and support for victims which took place on the 27 June 2008 at the Classic Hotel in Nicosia, Cyprus.

The conference provided a platform to present and discuss the main findings of the research carried out in the five partner countries and was attended by NGO representatives, policy makers from a local and an EU level, public authorities including the Police, as well as experts in the field of violence against women.

Opening remarks were made by the Minister of Justice and Public Order, Dr Kypros Chrysostomides. Guest speakers included Colette De Troy, Coordinator of the European Women's Lobby, Joanna Lovett, Research Fellow, Child & Woman Abuse Studies Unit - London Metropolitan University, and Dr. Rickert Vaughn, Professor of Clinical Population and Family Health, Mailman School of Public Health, Columbia University. The event received extensive media coverage.


The Resource Book

Information Seminar

As part of the activities to disseminate the results of the project, an information seminar entitled "Date Rape Cases among Young Women" was conducted on the 23rd May 2008, at the University of Nicosia, Cyprus.

The main aim of the seminar was to provide general information on date rape and sexual violence among young women in order to raise awareness on the issue, discuss the results of the research

conducted in Cyprus, as well as exchange information and experience among relevant stakeholders with the aim to develop recommendations for the prevention of date rape and support of victims on a national and European level.

Euro-Mediterranean Youth Forum for Gender Citizenship Education

MIGS has recently concluded the project entitled Euro-Mediterranean Youth Forum for Gender Citizenship Education funded by Anna Lindh Foundation for Dialogue between the Cultures. The main aim of the project was to create an innovative Gender Citizenship Education resource in the form of video documentaries with the aim to increase awareness among youth on gender equality and women's economic, social and political marginalization in the Mediterranean region. The project's objective was to allow young people to be actively involved in understanding and transforming their society.



Documentaries addressing Gender [In]equality in the Mediterranean

The project came to a close with the successful completion of the production of five short video documentaries, produced by five groups of young women and men from Cyprus, Egypt, Palestine, and Spain. The documentaries were produced in close collaboration with MediaZone, University of Nicosia. The documentaries address issues such as rural women and education in Egypt, women living with conflict in Palestine, violence against women and gender and migration in Spain, and trafficking in women for sexual exploitation in Cyprus. Daphne II- Secondary Education Schools and Education in Values



The Daphne II project *Secondary Education Schools and Education in values: Proposals for gender violence prevention* to which MIGS was a partner, is now in its final phase. The project was implemented in Cyprus, Spain and Malta with the aim to identify and analyse the types of values in secondary school that affect male and female models of attraction and their connection to gender violence.



The Cypriot case study revealed that there is a lack of understanding among adolescents on what a healthy intimate relationship consists of and therefore attitudes that in other cases could have been considered violent or abusive are tolerated and normalized within the Cypriot context. The strong persistence of traditional gender stereotypes among the young generation of Cypriots tends to support and perpetuate these violent attitudes.

Seminar for Education Practitioners



Role of Women in Economic Life (RWEL) Programme



The Role of Women in Economic Life (RWEL) Programme is a three year regional programme addressing and focusing on women's economic empowerment. Funded by the European Commission and implemented by the British Council in partnership with the Mediterranean Institute for Gender Studies (MIGS), the programme has supported public institutions and civil society in their efforts to promote women's economic participation in 10 South Mediterranean countries: Algeria, Egypt, Israel, Jordan, Lebanon, Morocco, Palestine, Syria, Tunisia, and Turkey.

The programme's recent activities include a Consultative Meeting on Women's Economic Participation in the South Mediterranean Region that took place in Cairo on 26th-27th May 2008.

The meeting experts presented the eight country studies on "Analysis of the Economic Situation of Women" and the "Comparative Analysis of the Economic Situation of Women in ten South Mediterranean countries", which were designed to investigate women's current economic position in the MEDA countries, taking into account the interlinked social, economic and cultural factors and existing institutional legal framework, with the aim of arriving at recommendations, which at a later stage will be voiced out at policy making levels. As the programme reaches its conclusion, the Euromed Policy Conference titled "Women's Economic Rights: Making a difference in the Mediterranean" is scheduled to take place on 17-18 of November 2008.

The conference will bring together national and regional policy and civil society experts, donor agencies, national authorities, and others and will provide a platform for debate for a wider MEDA network; the promotion of policy and legal recommendations; the dissemination of study findings & good practices; and the enhancement of the visibility on women's economic participation and empowerment.

The participants will discuss proposals to address the main challenges to women's economic participation in the region and decide on follow-up actions, as well as the best strategies to enrich the development of the new ENPI South Regional programme: Enhancing Equality between Women and Men in the Euromed region.

APROPOS Multisectoral and Multidisciplinary Professional Specialization Programme and Network for Violence Prevention



MIGS is partner in the project *APROPOS - Multisectoral and Multidisciplinary Professional Specialization Programme and Network for Violence Prevention* coordinated by Women's and Gender Studies, University of Oulu in Finland. The project is funded by the DAPHNE II programme of the European Commission and co-financed by Finland's Ministry of Social Affairs and Health. The project aims to construct a regional, national and international network of professionals working and dealing with questions of violence. The main result of the project will be a multi-sectoral and multidisciplinary specialization programme for professional education and in-service training on violence and violence prevention.

The courses offered as part of the project were piloted during the period 11/2007-05/2008 and were offered both in Finnish and in English and executed in an online environment called 'OPTIMA'. Courses were conducted online by 'mentors' from the partner organizations with more than 200 students participating from Finland and other European countries. The course was completed by 100 students, some taking all 5 courses and others only taking one or more.

The main aim of this project is to formulate a new business culture and develop family friendly forms of work organization, with the support of

businesses willing to integrate new strategies and adopt "reconciliation plans" for the development of a business culture friendly towards women and a suitable working environment.



The project, which has run for a period of three years, held its closing ceremony on the 27th May 2008 at the Cleopatra Hotel in Nicosia, Cyprus. MIGS hosted the *365 Violence Against Women Poster Exhibition* from the 7th-12th of June, 2008 at the ARTOS Cultural and Research Foundation in Nicosia.

The *Violence against Women 365 International Poster Exhibition* is an exhibition developed by Colm Dempsey, a member of An Garda Síochána [Irish Police] who hoped to reach the number of 365 posters in order to raise awareness on

the issue of violence against women worldwide. Based in Ireland the posters have now by far exceeded the original idea with the exhibition including posters by individuals, agencies and organisations from 58 countries around the world. Posters included in the exhibition feature many forms of violence such as child sexual abuse, rape, sexual assault, domestic abuse and sexual exploitation. Susana Pavlou, Director of MIGS, attended the ATHENA3 Annual Meeting which took place in conjunction with the 10th Women's Worlds Congress 2008 that took place at the Universidad Complutense de Madrid in Madrid on the 3- 9 July, 2008 (www.mmww08.org). The ATHENA meeting was a great success: the working groups worked extremely hard, a number of new ATHENA publications were announced, and many ATHENA3 members had the opportunity to present their work at the Women's World Congress giving our work a global perspective. MIGS participates in the ATHENA working group on "Strengthening the Societal impact of Women's Studies". During the working groups meeting Susana Pavlou presented the results of the mapping study undertaken by MIGS on the [Integration of Female Migrant Domestic Workers](#) within the framework of a project funded by the European Commission, INTI Preparatory Actions 2006 Programme.

In Madrid, representatives of three European women's studies associations WISE (www.wise.medinstgenderstudies.org), AOIFE (www.let.uu.nl/aoife) and ATHENA3 (www.athena3.org) presented the plans for a foundation of the European Association



for Gender Research, Education and Documentation (ATGENDER). ATGENDER will be founded as a broad association for academics, practitioners, activists and institutions in the field of Women's and Gender Studies, Feminist Research, women's rights, gender equality and diversity. The association will create a permanent structure for the growing field of knowledge and practice in Europe. Susana Pavlou, as a board member of WISE, is serving on the founding committee of the association and will serve on its board for the first three years upon which new elections will take place.

Violence against Women: MIGS at the Cyprus Parliament

As a result of MIGS' press release on violence against women which was released on 24th May 2008, the Institute was invited to the Cyprus Parliament, Committee of Equal Opportunities between Women and Men to present its activities, positions and recommendations on Violence against Women.

Trafficking in Women: MIGS at the Cyprus Parliament

On June 18, 2008 MIGS was asked to present the research results of the project "Mapping the Realities of Trafficking in Women for the purpose of Sexual Exploitation in Cyprus" to the Committee of Equal Opportunities at the House of Parliament. The recommendations of the Institute were welcomed by the Committee who arranged a second meeting on June 25, 2008 where representatives of all relevant ministries and other governmental were asked to attend and respond to specific questions arising from MIGS research report. Representatives of the Institute were asked to participate as observers.

Cyprus Coordinating Multidisciplinary Group on Trafficking in Persons

MIGS has been selected to become a member of the Coordinating Multidisciplinary Group on Trafficking in Persons. The group was established by the Law on Combating Trafficking and Exploitation of Human Beings and Protection of Victims (L.87(1/2007)). The group's purpose, among others, is to monitor the implementation of the Law and National Action Plan on Trafficking in Persons (2005) as well as to take all necessary measures, to monitor and evaluate the national referral mechanism of the



victims and to collect, exchange information between the members of the team with regards to offences as these are foreseen by the law. Some of the agencies participating in the group include the Attorney General's Office, the Ministry of Interior, the Ministry of Labour and Social Insurance, the Ministry of Foreign Affairs, the Police anti-trafficking unit, the National Machinery for Women's Rights as well as two NGOs, MIGS and the NGO Stigma.
